ESTABLISHMENT OF THE POSITIONS OF CHIEF ASSISTANT DEPUTY COMMISSIONER, ASSISTANT DEPUTY COMMISSIONER IN CHARGE OF INVESTIGATIONS, COUNSEL TO THE DEPUTY COMMISSIONER, SENIOR INVESTIGATIVE COUNSEL, DIRECTOR OF ADMINISTRATION, DIRECTOR OF INFORMATION SYSTEMS, CHIEF INVESTIGATOR AND DEPUTY CHIEF INVESTIGATOR (2) IN THE OFFICE OF THE DEPUTY COMMISSIONER OF INVESTIGATION FOR THE CITY SCHOOL DISTRICT OF THE CITY OF NEW YORK

The following resolutions are presented for adoption:

WHEREAS, by Executive Order No. 11 of 1990, the Mayor of the City of New York, in cooperation with the Board of Education and the Chancellor, established the position of Deputy Commissioner of Investigation for the City School District of the City of New York; and

WHEREAS, at a Special Meeting on June 27, 1990, the Board of Education resolved, in part, that the salaries and expenses of the Deputy Commissioner and his or her staff shall be borne by the Board of Education, within a budgetary allocation to be mutually agreed upon by the Board of Education and the City, provided, however, that such budgetary allocation shall be adequate to ensure the effective and independent performance of the duties and responsibilities of the Deputy Commissioner; and

WHEREAS, the Deputy Commissioner of Investigation was appointed in October 1990 and has subsequently determined his organizational structure and management staffing, which has been approved by the City Department of Personnel; and now, therefore, be it

RESOLVED, that the position of Chief Assistant Deputy Commissioner be hereby established as a Level IX position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the position of Assistant Deputy Commissioner in charge of Investigations be hereby established as a Level IX position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the position of Counsel to the Deputy Commissioner be hereby established as a Level VIII position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the position of Senior Investigative Counsel be hereby established as a Level VII position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the position of Director of Administration be hereby established as a Level VII position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the position of Director of Information Systems be hereby established as a Level V position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the position of Chief Investigator be hereby established as a Level VII position in the Board of Education Management Pay Plan; and be it further

RESOLVED, that two positions of Deputy Chief Investigator be hereby established as Level V positions in the Board of Education Management Pay Plan; and be it further

RESOLVED, that the Ceputy Commissioner of Investigation shall have sole jurisdiction over all employees within the Office of the Deputy Commissioner, including but not limited to, the authority to set salaries within established levels, to hire and terminate services, in accordance with applicable law and regulations and within the budgetary allocation mutually agreed upon by the Board of Education and the City.

EXPLANATION

This resolution implements, in part, the Mayor's Executive Order No. 11 of 1990 and the resolution of the Board of Education adopted on June 27, 1990 by establishing those management positions deemed necessary to carry out the functions of the newly created Office of the Deputy Commissioner of Investigation for the City School District. The positions and levels have been approved by the City Department of Personnel and are being made part of the Board of Education's Management Pay Plan for payroll purposes. It is understood that once the Deputy Commissioner's management staffing is regularized, the Deputy Commissioner shall inform the Board of those management positions previously established in the Office of the Inspector General which are no longer needed.
